Purposes, legal basis

In doing so, we process your personal data such as address and contact data, information on conversations held, your requirements, offers and other information that we receive from you.

If external partners are involved in the provision of services or the fulfillment of orders, the information necessary for the provision of their services may be passed on to them.

Data disclosure to third parties

Deletion or blocking of the data

We adhere to the principles of data avoidance and data economy. We therefore only store your personal data for as long as is necessary to achieve the purposes stated here or as stipulated by the legislator (e.g. German Commercial Code (HGB), Fiscal Code (AO) and other laws and regulations) manifold storage periods. After the respective purpose has ceased to exist or these periods have expired, the corresponding data is routinely blocked or deleted in accordance with the statutory provisions.

If, for example, you do not want us to continue storing your personal data after the expiry of statutory retention periods, please let us know when you leave our company.

Please note that in this case we will not be able to assist you later if you wish to prove social security periods to the pension insurance.
